# **Release Notes for CounterPath Bria iPhone Edition Version 1.3.0**

## New Features for Bria iPhone Edition 1.3.0

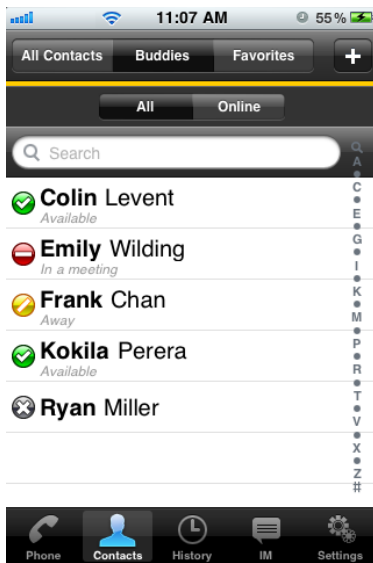
### Presence and Instant Messaging

Bria iPhone Edition now supports presence and instant messaging for the XMPP and SIP SIMPLE protocols.

This feature is available as an **in-app purchase**. You need to purchase this feature separately in addition to Bria itself. To use this feature for SIP SIMPLE, your VoIP service provider also must support SIP SIMPLE.

With presence and instant messaging, you can:

- Create multiple XMPP accounts using Gmail and Facebook account credentials.
- Send and receive text-based instant messages with your contacts.
- Send SMS messages to PSTN cell phone numbers if your VoIP service provider supports this feature.
- Publish your online status to your contacts, and also see when your contacts are available/away/busy.



### Setting up Presence and Messaging on your Bria

Either you have upgraded your Bria from the previous version or just bought a Bria for the first time, you need to purchase the Presence and Messaging feature separately. If you plan to use presence and messaging over SIP SIMPLE, make sure your VoIP service provider supports SIP SIMPLE before purchasing this feature.

To purchase this feature and set up your Bria:

1. Start Bria on your iPhone.
2. Go to Settings > Premium Features.
3. Tap the price and follow the prompts to purchase the Presence and Messaging feature. After your purchase is approved, the IM tab appears at the bottom of your Bria.
4. Set up your Bria to use this feature. Follow the steps in Section 2.4 of Bria *iPhone Edition* User Guide.

## Known Issues

### Purchasing Premium Features

On the Premium Features screen when you purchase two items at once, the second item may not be installed in the device. To resolve this problem, quit Bria after purchasing the first feature, and restart Bria to purchase the second one.
